I certify I am legally authorized to sign on behalf of and bind the above listed entity(s). <p>The GESC Plan Permit is granted with the explicit understanding that it is the Permittees' responsibility to:</p> <ol style="list-style-type: none"> 1. Allow The City of Castle Pines unrestricted access to the site to conduct regular site inspections; 2. Comply with all requirements of the GESC Manual, accepted GESC plan, and GESC permit; 3. Immediately cease land-disturbing activities upon receipt of a written Stop Work Order from an authorized representative of The City of Castle Pines. A Stop Work Order shall be issued and this Permit revoked if the Permittees are not in compliance with the GESC Permit, GESC Plan and/or GESC Manual, or the Permittees fail to take corrective action within the time specified on the written notification of such non-compliance; 4. Understand that in addition to other remedies, a violation of this GESC Permit shall constitute a violation of Section 31 of the City of Castle Pines Zoning Ordinance; and 5. Understand any approval obtained from the City of Castle Pines does not obviate your need to comply with the requirements of the State of Colorado Department of Public Health and Environment, Colorado Discharge Permit System, General Permit, and Sections 7 and 9 of the Endangered Species Act of 1973, 16 U.S.C. 1531, <u>et seq.</u>, as amended, or with any other applicable federal, state, local laws, or regulations.
