- <u>Section 1</u>. The foregoing recitals are incorporated herein by reference as findings and determinations of Council.
- Section 2. The City Council of the City of Castle Pines hereby amends Resolution 24-08 such that the Second Voting Seat for the Douglas County Housing Partnership shall now read:

"Community Development Director, Donna Ferguson."

- <u>Section 3.</u> <u>Original Terms and Conditions</u>. Except as amended herein, the original terms and conditions of Resolution 24-08 remain in full force and effect.
- <u>Section 4.</u> <u>Severability.</u> If any section, paragraph, clause, or provision of this Resolution is held to be invalid or unenforceable by a court of competent jurisdiction, the invalidity or unenforceability of such section, paragraph, clause, or provision shall not affect any of the remaining sections, paragraphs, clauses, or provisions of this Resolution.
 - <u>Section 5</u>. This Resolution shall take effect upon its approval by the City Council.
